ROBERT C. HARRIS and EVELYN L. HARRIS,

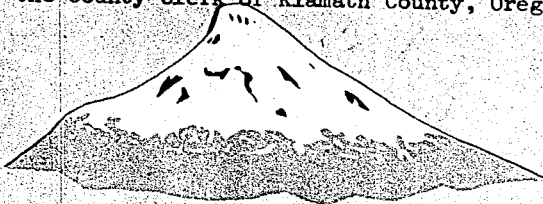
