W. 1/4, A DISTANCE OF 390.00 FEET; THENCE WESTERLY AND PARALLEL TO THE NORTH LINE OF SAID N.E. 1/4 N.W. 1/4 894.00 FEET; THENCE SOUTHERLY AND PARALLEL TO THE EAST LINE OF SAID N.E. 1/4 N.W. 1/4 100.00 FEET, THENCE EASTERLY AND PARALLEL TO THE NORTH LINE OF SAID N.E. 1/4 N.W. 1/4 894.00 FEET TO THE EAST LINE OF SAID N.E. 1/4 N.W. 1/4; THENCE NORTHERLY ALONG THE EAST LINE OF SAID N.E. 1/4 N.W. 1/4 100.00 FEET TO THE POINT OF BEGINNING.

And said grantor hereby covenants to and with said grantee and grantee's heirs, successors and assigns, that grantor is lawfully seized in fee simple of the above granted premises, free from all encumbrances
