Notice of Location of Placer Claim

STATE of OREGON, County of Klamath

Mining District.

NOTICE HEREBY IS GIVEN That the undersigned locators, each a citizen of the United States or one who has declared his intention to become such, have discovered a placer deposit of locatable minerals upon the public domain of the United States which is open to mineral entry and location within the above state, county and mining district; and, in accordance with the laws of the United States and the State of Oregon, have located and hereby do locate a placer claim of 20 acres by posting this notice of location on a post or monument in a conspicuous place inside the boundaries of the claim. The claim is named the Mazama M.C. #13 (Thirteen) Claim, which is described as follows (fill out one of the two sections below):

The location of this claim is distinctly marked on the ground so that the boundaries of the claim may be readily traced: Starting at the Northwest corner of Section 6, T2 S5, R1 E, W M13, thence South 1320 feet (approx.), thence in a West direction 660 feet, more or less, to the beginning point of the description of the placer claim hereby located, to-wit: a substantial post set in the ground, marked Post No. 1;

thence 660 feet in a South direction to a post marked No. 2;

thence 1320 feet in a West direction to a post marked No. 3;

thence 660 feet in a South direction to a post marked No. 4;

thence 660 feet in a West direction to a post marked No. 5;

thence 1320 feet in a South direction to a post marked No. 6;

thence 1320 feet in a West direction to a post marked No. 7;

thence 1320 feet in a South direction to a post marked No. 8;

This claim is situated in the Northeast (quarter section) of Section 1 (one), Township, Range 6 East, of the Willamette Meridian, as protracted the land is unsurveyed, in the State of Oregon.

The location notice post stands Southwest of Post #1.

The locators intend to hold and work the above described claim as provided by the laws of the United States and the State of Oregon and claim all of the rights and privileges granted by existing laws and customs. In construing this location notice, the singular includes the plural and vice versa if the context so requires.

The adjoining claims are Mazama M.C. #14 on the West, #18 on the North, and #12 on the East.
