The Soldier's and Sailor's Relief Act

The Soldier's and Sailor's Relief Act (50 USC App., Sections 501-591) suspends legal proceedings that would prejudice the rights of military personnel on active duty. It applies to foreclosures of Trust Deeds on the property owned by a person in the military, but executed prior to induction into the service. It does not apply to Trust Deeds executed while a person is in the service.

If the deed of trust was executed prior to induction into the service, no sale is valid if made during the period of military service or within three months thereafter, except when the sale is made on written agreement of the parties or on a court order. The trustee must determine whether or not the record owner is in the military. This is usually accomplished by the beneficiary filing an affidavit of non-military service. If in the military, the sale may still take place if the Trust Deed was executed while the record owner was actually in the service.
