CORRECTION DEED

WHEREAS, the UNITED STATES OF AMERICA conveyed to WEYERHAEUSER COMPANY an easement for a road by deed, dated September 21, 1970, and recorded on April 16, 1971, in Volume 157 at page 577, and rerecorded on October 4, 1971, in Book 159 at page 112 of the Records of Lake County, Oregon and recorded on April 6, 1971, in Volume M71 at page 2842, and rerecorded on October 11, 1971, in Volume M71 at page 10644 of the Records of Klamath County, Oregon and

WHEREAS, the description, as it pertains to Road No. 379.011, listed under Township 38 South, Range 15 East of W.M., on Exhibit A, page 6 of 9, of said easement deed, is incomplete and inaccurate, and

WHEREAS, the location of said Road No. 379.011 is incorrectly depicted on Exhibit B-2 of said easement deed, and

WHEREAS, said easement deed was intended to describe Road No. 379.011 as shown on the attached Exhibit 1 and described as follows:

Road No. 379.011 beginning at its intersection with Road No. 379 in the SW4NE4 of Section 9, T.38S., R.15E., W.M. and ending at its intersection with Road No. 375 in the NE4SE4 of Section 7, T.38S., R.15E., W.M. and crossing lands of the UNITED STATES OF AMERICA in the SW4NE4 of Section 9, and the N4NE4 of Section 17, and crossing lands over which the UNITED STATES OF AMERICA can grant easement rights in the NE4SE4 of Section 7, all in T.38S., R.15E., W.M.

NOW THEREFORE, Exhibit A, page 6 of 9, of the aforesaid easement deed executed by the UNITED STATES OF AMERICA on September 21, 1970 is hereby amended as follows:

Section 8, T.38S., R.15E., W.M.

and Exhibit 1, attached hereto, is deemed to correctly depict the location of said Road No. 379.011.

EXCEPT as amended by this Correction Deed, all other terms and conditions of said Easement Deed of September 21, 1970, above referred to, shall remain in full force and effect.
