NOTICE HEREBY IS GIVEN That the undersigned locators, each a citizen of the United States or one who has declared his intention to become such, have discovered a placer deposit of locatable minerals upon the public domain of the United States which is open to mineral entry and location within the above state, county and mining district; and, in accordance with the laws of the United States and the State of Oregon, have located and hereby do locate a placer claim of 160 acres by posting this notice of location on a post or monument in a conspicuous place inside the boundaries of the claim. The claim is named the Sunago NE #24 (Twenty-Four) Claim, which is described as follows (fill out one of the two sections below):

(1) If claim is on surveyed land:

This claim comprises the Southeast Quarter of Section 25 (Five) Township 29 South, Range 6 East, of the Willamette Meridian, in the State of Oregon.

The location of this claim is distinctly marked on the ground so that the boundaries of the claim may be readily traced: Starting at the location post stands just Northwest of the Southeast corner of Section 25 being a U.S. government surveyed corner.

(If possible, name some government survey corner; otherwise describe some natural object or permanent monument in the vicinity) thence in a direction feet, more or less, to the beginning point of the description of the placer claim hereby located, to-wit: a substantial post set in the ground, marked Post No. 1;

thence feet in a direction to a post marked No. 2;

thence feet in a direction to a post marked No. 4;

thence feet in a direction to a post marked No. 5;

thence feet in a direction to a post marked No. 6;

thence feet in a direction to a post marked No. 7;

thence feet in a direction to a post marked No. 8;

This claim is situated in the Range (quarter section) of Section 25, Township 29 South, Range 6 East, of the Willamette Meridian, either as surveyed by the U.S. Government or protracted if the land is unsurveyed.

(2) If claim is on unsurveyed public land or land on surveyed land, and it is not practicable to describe claim by legal subdivisions:
The distance between posts may not exceed 1320 feet.
The number of posts will vary depending on the size of the claim.

The locators intend to hold and work the above described claim as provided by the laws of the United States and the State of Oregon and claim all of the rights and privileges granted by existing laws and customs. In construing this location notice, the singular includes the plural and vice versa if the context so requires.

The adjoining claims are Sunago NE #25 on the North and #23 on the South.
