QUITCLAIM DEED

FOR VALUE RECEIVED, and in accordance with the Act of February 2, 1911, (36 Stat. 895, 43 U.S.C. Section 374) the United States of America does quitclaim unto Mike Lehman and his heirs, successors and assigns forever, all of the right, title and interest, if any, of the United States of America in and to the following described real property situated in the County of Klamath, State of Oregon:

A tract of land in Sections Fourteen (14) and Fifteen (15), Township Thirty-nine (39) South, Range Ten (10) East, Willamette Meridian, County of Klamath, State of Oregon; said tract of land being all that portion of the real property conveyed by deed from Frank P. Corpening, et ux., to the United States of America dated March 16, 1911, and recorded March 16, 1911, in Volume 34 at page 158 of the Official Records of said county, and described as follows:

All that part of Lot 1, Section 15 and Lot 6, Section 14, Township 39 South, Range 10 East, Willamette Meridian, described as follows:

Beginning 1,756 feet south of the quarter corner common to Sections 14 and 15; thence South 66045' West 254 feet; thence South 54015' West 613.4 feet; thence South 58032' West 673.3 feet; thence South 14 feet to bank of Lost River; thence easterly along the north bank of said river to a point in Section 14, bearing North 66045' East 323.8 feet from point of beginning; thence to point of beginning, containing 5.56 acres.

SUBJECT TO easements or rights-of-way existing or of record in favor of the public or third parties.

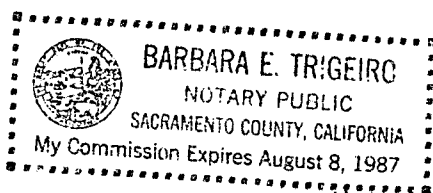
