WHEREAS, pursuant to a Judgment Decree and Order of the

WHEREAS, in pursuance of the laws of the State of Oregon and for and in consideration of the Judgment Decree and Order and Sale as aforesaid, I have this day executed this deed conveying to Klamath County, a political subdivision of the State of Oregon, the following-described real properties, to wit:

Said described parcels of real property were formerly owned by the said defendants indicated, bearing the tax-foreclosure list number as indicated and for the amount of judgment as indicated, all respectively, for each parcel sold by said foreclosure to the said Klamath County, Oregon, and not redeemed as provided by law;

JEAN ELZNER, Grantor as aforesaid, in consideration of the premises and by virtue of the statutes of the State of Oregon, in such cases made and provided, do hereby grant, bargain, sell, and convey unto Klamath County, Oregon, as grantee aforesaid, and its assigns forever, the parcels of real property hereinbefore described as fully and completely as Grantor can by virtue of the premises convey the same.
