THIS AGREEMENT is entered into on the day and year hereinafter set out between EARL W. HANNEN, Seller, and RUSSELL C. JOHNSON and ALICE A. JOHNSON, Purchaser.

This agreement amends that contract of sale dated June 10, 1982, / between the same parties, which contract of sale /and recorded June 11, 1982 in Volume 358 page 213 Deed Records of Deschutes County describes certain real property in Deschutes County, Oregon. Except as amended and stated herein, said contract remains in full force and effect.

The parties hereto agree that as of December 10, 1986, the balance due, including interest accrued, is \$42.775.34. Purchaser, in consideration of the covenants contained herein, covenants to pay to Seller on said contract of sale the sum of \$12,775.34 on or before December 10, 1986.

Thereafter, from and after December 10, 1986, Purchaser covenants to pay to Seller toward said contract the sum of \$500 per month, with the first payment to be due on or before the 10th day of January, 1987, and each payment thereafter to be due on or before the 10th day of each month thereafter until the entire balance and interest accrued is paid. The balance remaining shall accrue interest at the rate of 13% per annum from December 10, 1986, until paid. Each monthly payment will be first applied to all interest accrued and thereafter applied to the principal balance.

Notwithstanding anything contained herein, or in the original contract of sale, the entire balance and all accrued interest shall be fully paid on or before January 10, 1989.
