for the consideration hereinafter stated, does hereby remise, release and quitclaim unto Darwin J. and Maxine M. Robnett, husband and wife hereinafter called grantee, and unto grantee's heirs, successors and assigns all of the grantor's right, title and interest in that certain real property with the tenements, hereditaments and appurtenances thereunto belonging or in any wise appertaining, situated in the County of Klamath, State of Oregon, described as follows, to-wit:

PARCEL I: A tract of land located in the West 1/2 of the Northwest 1/4 of the Southwest 1/4, Section 27, Township 35 South, Range 7 East of the Willamette Meridian, Klamath County, Oregon. From West 1/4 corner of Section 27, South along section line 264 feet to a steel pin, the point of beginning, East 330 feet, then South along line parallel with Section Line 27, 264 feet to a pin, then West 330 feet to a pin in section line 27, then North along Section 27, 264 feet to the point of beginning.

PARCEL II: From the NW corner of the NW 1/4 of SW 1/4 of Section 27, Township 35 South, Range 7 East of the Willamette Meridian, Klamath County, Oregon, East along North line of said NW 1/4 of SW 1/4 330 feet to an iron pin; thence South and parallel to section line of said Section 27, 264 feet to an iron pin, the true point of beginning. Thence East and parallel with North line of NW 1/4 of SW 1/4, 198 feet to an iron pin; thence South and parallel with section line of said Section 27, 264 feet to an iron pin; thence West and parallel with North line of NW 1/4 of SW 1/4, 198 feet to an iron pin; thence North 264 feet to the true point of beginning.
