KNOW ALL MEN BY THESE PRESENTS, That

FRANK C. BURR and GERTRUDE M. BURR, husband and wife

hereinafter called the grantor, for the consideration hereinafter stated, to grantor paid by

WILLIAM E. KOONTZ

the grantee, does hereby grant, bargain, sell and convey unto the said grantee and grantee's heirs, successors and assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, situated in the County of Klamath and State of Oregon, described as follows, to-wit:

The N $\frac{1}{2}$ SE $\frac{1}{4}$ SW $\frac{1}{4}$ NW $\frac{1}{4}$  of Section 16, Township 28 South, Range 8 West of the Willamette Meridian, EXCEPTING THEREFROM that portion on the West line that lies within Old Oregon Trunk Railway right of way conveyed by Deed recorded November 14, 1910, in Book 30 page 377, Deed Records.

and that grantor will warrant and forever defend the said premises and every part and parcel thereof against the lawful claims and demands of all persons whomsoever, except those claiming under the above described encumbrances.
