PLEASE TAKE NOTICE THAT:

The LASSEN PRODUCTION CREDIT ASSOCIATION has merged into  
the NEVADA LIVESTOCK PRODUCTION CREDIT ASSOCIATION to form the  
SIERRA NEVADA PRODUCTION CREDIT ASSOCIATION, effective December  
1, 1986.

THE above-named Production Credit Associations, being  
chartered instrumentalities of the United States existing under  
the provisions of the Farm Credit Act of 1971, are subject to the  
supervision of the Federal Intermediate Credit Bank of Sacramento  
and of the Farm Credit Administration, an independent agency in  
the Executive Branch of the Federal Government.

IN accordance with the authority of an administrative  
order of the Farm Credit Administration on or about December 1,  
1986, the Articles of Incorporation and the Certificate of  
Territory to be Served of the Lassen Production Credit  
Association were amended pursuant to Sections 4.12 and 5.17 of  
the Farm Credit Act of 1971 (12 U.S.C. §2183) and Regulations  
promulgated thereunder at 12 C.F.R. §§614.1122 - 614.1123 to  
provide that the name of the continuing Association shall  
henceforth be the Sierra Nevada Production Credit Association and  
to provide that the territory served by the Sierra Nevada  
Production Credit Association shall henceforth encompass the


territories formerly served by the Lassen and Nevada Livestock Production Credit Associations.

THE business formerly conducted by the Lassen Production Credit Association and by the Nevada Livestock Production Credit Association has been succeeded to and is now being conducted by Sierra Nevada Production Credit Association, with all of the powers and authority of the above-named individual Production Credit Associations prior to said merger. The Sierra Nevada Production Credit Association is liable for any and all obligations incurred by the Lassen and Nevada Livestock Production Credit Associations and is successor to any and all contractual rights of the Lassen and Nevada Livestock Production Credit Associations.

The Sierra Nevada Production Credit Association is empowered to reconvey, release, discharge or assign deeds of trusts, mortgages, and other security instruments of whatever nature made in favor of Lassen or Nevada Livestock Production Credit Association or wherein Lassen or Nevada Livestock Production Credit Association is named trustee, mortgagee, secured party, or beneficiary or has become such by virtue of assignment of said security instrument or by virtue of indorsement of the note secured by said security instruments.



**MERGER ADOPTION RESOLUTION  
OF THE BOARD OF DIRECTORS OF  
THE SIERRA NEVADA PRODUCTION CREDIT ASSOCIATION**

**WHEREAS**, by Resolutions duly passed by the Boards of Directors of the Lassen Production Credit Association and the Nevada Livestock Production Credit Association ("the merging Associations"), the Directors of the above named Associations have authorized the merger of the said Associations; and

**WHEREAS**, the proposed merger has been duly approved, in accordance with statutory and regulatory authority, by the Stockholders of each of the merging Associations, the Federal Intermediate Credit Bank of Sacramento, and the Farm Credit Administration.

**NOW, THEREFORE, BE IT RESOLVED** that this Association is hereby formed, pursuant to the merger of the Lassen Production Credit Association and the Nevada Livestock Production Credit Association, and shall be the continuing association and successor in interest to the merging Associations; and

**BE IT FURTHER RESOLVED** that the continuing Association is hereby authorized to change its name to the Sierra Nevada Production Credit Association and to be known as such from December 1, 1986 and thereafter; and

**BE IT FURTHER RESOLVED** that the Directors reaffirm that all the legal rights, title, and interest of the Lassen and Nevada Livestock Production Credit Associations shall vest in the Sierra Nevada Production Credit Association without impairment of any kind; and

**BE IT FURTHER RESOLVED** that the officers of this Association are hereby authorized and directed to perform all actions prescribed by the Farm Credit Act of 1971 and regulations promulgated thereunder to effectuate this merger and change of name and to do all things necessary, incident, and proper under said authority to carry out the intent and purpose of this Resolution; and

**BE IT FURTHER RESOLVED** that the President and Vice President of this Association are hereby authorized and directed to execute such documents of title and such other instruments and assurances, in the name of the Lassen Production Credit Association or in the name of the Nevada Livestock Production Credit Association as may be necessary and proper to carry out the purposes and intent of this Resolution.
