KNOW ALL MEN BY THESE PRESENTS, That CORLISS FERNLUND who took title as

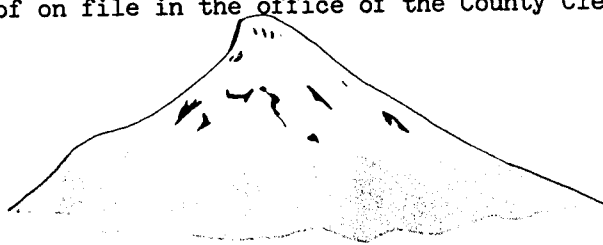
