On October 7, 1986 you were sent a notice of failure to file a timely First Pre-Election Statement of Contributions and Expenditures for the General Election by 5:00 p.m. of October 14, 1986 as required by ORS 260.073. In that notice you were given an opportunity to request a Hearing and explain any mitigating circumstances which might have caused the late filing. A copy of that notice is enclosed. However, since this office received no such request from you, a civil penalty was assessed.

On December 30, 1986, you were sent a notice and order imposing a civil penalty for failure to file timely the above mentioned report. The notice stated that a civil penalty was imposed in accordance with ORS 260.232, and that if payment was not received a Final Notice of Assessment would be recorded in the County Clerk Lien Record. A copy of that notice is enclosed. Since payment has not been received we are now recording the civil penalty assessed in the County Clerk Lien Record.

The maximum amount of penalty that may be imposed is 5% of the total contributions or expenditures required to be reported in the statement, whichever is greater, per day, including weekends, for the period of October 14, 1986 to November 28, 1986.

YOU ARE HEREBY ASSESSED a civil penalty of \$25.00 dollars in accordance with ORS 260.232, for failure to file by October 14, 1986 a First Pre-Election Statement of Contributions and Expenditures for the General Election of November 4, 1986. This statement was received in the filing office on November 28, 1986.

This order shall be recorded in the County Clerk Lien Record of Klamath County. Please remit payment to our office and refer to the account number shown above.
