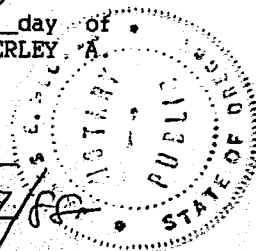

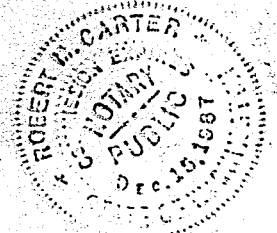

The following described real property situate in Klamath County, Oregon, to-wit:

Beginning at the Northeast corner of the SE $\frac{1}{4}$ NE $\frac{1}{4}$ of Section 34, tp. 39 S. R. 9 E.W.M., thence South along the Section line 22.50 chains; thence Westerly at right angles with said Section line 20 chains; thence Northerly and parallel with the Section line aforesaid 22.50 chains, and thence Easterly 20 chains to the point of beginning, being the SE $\frac{1}{4}$ NE $\frac{1}{4}$ and five acres off the North end of the NE $\frac{1}{4}$ SE $\frac{1}{4}$ of said Section 34, tp. 39 S. R. 9 E.W.M., saving and excepting a ditch right of way over said property deeded to R. P. Breitenstein, by deed recorded in Book 55, at page 435, Deed Records of Klamath County, Oreg.

PARCEL NO. 1: All that portion of the NE $\frac{1}{4}$ SE $\frac{1}{4}$ of Section 34, tp 39 South of Rangae 9 E.W.M., in Klamath County, Oregon, described as follows: Beginning at a point in the east line of said Section 34, 1725 feet north of the Southeast corner of said section; thence North 88° West 1005.4 feet; thence through the arc of a 40° curve right 66.5 feet to a point bearing North 74°42' West 66.5 feet; thence North 61°23' West 202.5 feet; thence through the arc of a 40° curve right 147.5 feet to a point bearing North 32°38' West 140.6 feet; thence North 3°53' West 72.4 feet to a point in the West line of said NE $\frac{1}{4}$ SE $\frac{1}{4}$ of said section from which the quarter corner common to Sections 34 and 35, said township and range, bears North 66°28' East 1449 feet; thence North along the West line of said NE $\frac{1}{4}$ SE $\frac{1}{4}$ of said Section 34, 400 feet more or less, to a point 165 feet South of the Northwest corner of said NE $\frac{1}{4}$ SE $\frac{1}{4}$ of said Section 34, thence East parallel with the North line of said NE $\frac{1}{4}$ SE $\frac{1}{4}$ of said Section 34, 1320 feet, more or less, to the last line of said NE $\frac{1}{4}$ SE $\frac{1}{4}$ of said Section 34; thence South 750 feet, more or less, to the point of beginning. Less and excepting one-half of the county road along the West side of the herein described tract, one-half of the right of way of the U. S. R. S. C-4 Canal, and a strip of land one rod wide off the East side of the herein described tract heretofore deeded to the Klamath Irrigation District, said parcel containing 21 acres, more or less.
