Subject to reservations, restrictions, rights of way of record and those apparent upon the land; AND Mortgage, including the terms and provisions thereof in favor of State of Oregon, represented and acting by the Director of Veteran's Affairs, recorded Dec. 19, 1979 in Vol M79 page 29156, records of Klamath County, Oregon, which said mortgage grantees agrees to assume and pay.
