KNOW ALL MEN BY THESE PRESENTS, That

SIMS, husband and wife, hereinafter called the grantee, does hereby grant, bargain, sell and convey unto the said grantee and grantee's heirs, successors and assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, situated in the County of Klamath and State of Oregon, described as follows, to-wit:

Lots 16 through 28 in Block 5 Midland, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon.

Subject to reservations, restrictions, rights of way of record and those apparent upon the land;

AND Mortgage, including the terms and provisions thereof in favor of State of Oregon, represented and acting by the Director of Veteran's Affairs, recorded Dec. 19, 1979 in Vol. M-79 page 29156, records of Klamath County, Oregon, which said mortgage grantees agree to assume and pay
