BARNETT, husband and wife, hereinafter called the grantee, does hereby grant, bargain, sell and convey unto the said grantee and grantee's heirs, successors and assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, situated in the County of Klamath and State of Oregon, described as follows, to-wit: Lots 23 and 24, HIGHLAND PARK, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon. EXCEPTING THEREFROM, a parcel of land situated in Lots 23 and 24, HIGHLAND PARK SUBDIVISION, in the NE $\frac{1}{4}$ NE $\frac{1}{4}$ of Section 12, Township 39 South, Range 9 East of the Willamette Meridian, Klamath County, Oregon, more particularly described as follows: Beginning at the corner of common to Lots 11-12-23-24-32-and 33 thence South 46° 08' East along the Northeasterly line of said Lot 12, 30.15 feet; thence North 38° 11' East, parallel to and 30.00 feet distant from the Northwestern line of said Lot 24, 122.11 feet to the North line of said Lot 24; thence South 89° 56' West 38.20 feet to the Northwestern corner of said Lot 24; thence South 38° 11' East 95.5 feet to the point of beginning.

The true and actual consideration paid for this transfer, stated in terms of dollars, is \$ 32,406.36

In construing this deed and where the context so requires, the singular includes the plural and all grammatical changes shall be implied to make the provisions hereof apply equally to corporations and to individuals.
