Mr. Bradley is to repair + keep in good order and to have insurance on said International Truck + Trailer + 1973 Jeep 4x4 P.V. that is required by the State of Oregon, this also includes PUC, if required by the State of Oregon.

All payments to add up to a total of Ten Thousand + <sup>no</sup> 00 Dollars (10,000.00) in Five (5) years with the payments each year to total (2000.00) Two Thousand Dollars.
