WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS, That ERIKA ELLIOTT, who acquired title as ERIKA BERTUCH

hereinafter called the grantor, for the consideration hereinafter stated, to grantor paid by DAVID THOMPSON and ELIZABETH THOMPSON, husband and wife, hereinafter called the grantee, does hereby grant, bargain, sell and convey unto the said grantee and grantee's heirs, successors and assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, situated in the County of Klamath and State of Oregon, described as follows, to-wit:

Lot 16 in Block 45 First Addition to Klamath Forest Estates, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon.

Subject to:

2. Reservations and restrictions contained in the dedication of First Addition to Klamath Forest Estates.
