I, ONNIE SIIKANEN, of Grants Pass, Josephine County, Oregon, do hereby make, and declare this to be my Will.

Т

I direct that my just debts and funeral expenses be promptly paid. I direct my executrix to treat as an obligation of my estate and to pay, without any apportionment thereof, all estate, inheritance or other death taxes or duties imposed and made payable by reason of my death by the laws of the United States, or of any state, territory, or country. If any other person shall pay any such tax, my executrix shall reimburse such person.

ΤT

All the rest, residue, and remainder of my estate of whatsoever kind and wheresoever situate I give, bequeath and devise unto my wife, GRACE B. SIIKANEN, if she shall survive me.

III

In the event my said wife shall have predeceased me or should we both perish in a common disaster, then I give, devise and bequeath Fifteen Thousand Dollars (\$15,000.00) to MARIAN GRACE O'LERICK, in trust however for the use and benefit of my daughter BEVERLY INA SIIKANEN, for her education and maintenance during her minority and during the period of her college education, if any. This provision of my Will shall become operative only if the said Beverly Ina Siikanen shall not have reached the age of twenty-one (21) years at the time of my death, or shall not have finished her high school and college education at the time of my death.

The trust hereimabove created shall terminate upon the said Beverly Ina Siikanen completing her college education, or upon written notification by her to the trustee of abandomment of her college education. Upon termination the residue of the trust, both principal and interest shall be distributed to my children as provided in the paragraph following for distribution of the residue of my estate.

My trustee shall have the power:

(a) To manage, sell, convey, exchange, encumber, divide, subdivide, improve and maintain the trust estate or any part thereof; to create

restrictions, easements and other servitudes; to carry insurance in such amount and against such hazards as my trustee may deem advisable; to lease, license and create such other rights, privileges and interests as my trustee may deem advisable for terms within or extending beyond the duration of the trust.

(b) Upon any division or distribution of the trust estate, to partition, allot and distribute the trust estate in undivided interests or in kind at valuations determined by my trustee, or partly in kind and partly in cash,

and to sell such property as my trustee may deem appropriate.

(c) To give proxies, pay assessments and other sums deemed necessary by my trustee for the protection of the trust estate; to participate in voting trusts, pooling agreements, foreclosures, reorganizations, consolidations, mergers and liquidations, and in connection therewith to deposit securities with and transfer title to any protective or other committee or fiduciary; to exercise or sell stock subscription or conversion rights; to accept and retain as an investment any securities or other property, whether or not authorized by law for the investment of trust funds, received through the exercise of any of the foregoing powers.

(d) To advance funds for the benefit of the trust estate, or for the payment of any distributive share or interest, any such advance with interest at current rates to be a first lien upon the trust estate; to borrow money for such purpose as my trustee shall deem to be for the interest of the trust estate upon such terms and conditions as my trustee may deem proper.

- (e) To realize, by suit or otherwise, upon any promissory note or other chose in action, and in settlement thereof to compromise, discount, adjust, extend or abandon same.
- (f) To invest and reinvest the trust estate in such bonds, mortgages, debentures, preferred or common stocks or other real or personal property as my trustee may in her unrestricted discretion deem advisable.
- (g) To receive indemnity to her satisfaction before taking any step which may subject her to loss.
- (h) To resign her trusteeship hereunder at any time. In the event of such resignation, the trustee or any person interested in the trust may take such steps as may be necessary to secure the appointment of a new trustee in the manner provided by law.
 - (i) To employ such attorneys or agents as she may consider necessary.
- (j) To do all things she might do in the absence of the foregoing specific powers.

Any sales of property under this trust shall be confirmed and approved by the Courts as provided by law for the sale of real property in probate.

From the income of the trust estate, my trustee shall provide for the care, education and maintenance of my said daughter, Beverly Ina Siikanen, during the term of the trust, if the same is adequate, otherwise I charge the principal of the trust estate liable therefor.

In the event of my death before the said Beverly Ina Siikanen shall have reached her majority, I hereby appoint and nominate Marian Grace O'Lerick as testamentary guardian of said Beverly Ina Siikanen.
