NOTICE OF CLAIM
OF TIMBER LIEN

NOTICE IS HEREBY GIVEN that Kay S Burgett of Klamath County, State of Oregon, claims a lien (ORS 87.222) upon all those logs or proceeds thereof logged by claimant pursuant to a contract entered into between claimant and Alpine Veneers, Inc. re U.S.D.A. Forest Service Malone Timber Sale. The logging services were performed by claimant for owner in Section 23,26,27 &35, Township 35S, Range 6E, W.M., all in Klamath County, State of Oregon, and lying on Winema National Forest lands.

Claimant claims lien upon logs felled, bucked, decked and lying on the ground within the timber sale and right - of - way. The logs are unbranded.

The lien is for labor performed upon and assistance rendered in felling, bucking and decking the timber.

Claimant was engaged by Alpine Veneers, Inc., the holder of the Forest Service Timber Sale Contract above-described, to perform logging services, and/or construct improvements on the sale area including the construction of spur roads, landings and the like, all of which was required to convert standing or downed trees into logs now on the sale area.

Claimant has faithfully performed and complied with the terms of employment. Claimant ceased work on the logs and timber in question approximately February 19, 1987.

The amount of claimant's demand for said service is \$ 20,034.66, no part thereof has been paid, and there is now due and remaining unpaid thereon, after deducting all just credits and offsets, the sum of \$ 20,034.66 in which amount claimant claims a lien upon said logs and proceeds therefrom by anyone.


