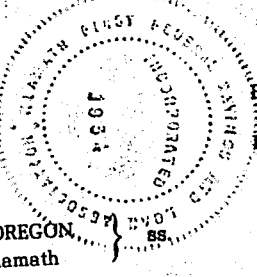
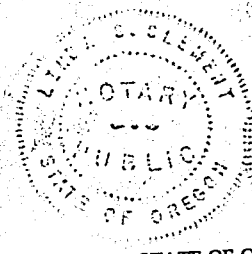
## SATISFACTION OF MORTGAGE
