QUITCLAIM DEED

KNOW ALL MEN BY THESE PRESENTS, That NICHOLAS SHOTWELL, hereinafter called grantor,

for the consideration hereinafter stated, does hereby remise, release and quitclaim unto

JOHN ROBERT MILLERhereinafter called grantee, and unto grantee's heirs, successors and assigns all of the grantor's right, title and interest in that certain real property with the tenements, hereditaments and appurtenances thereunto belonging or in any wise appertaining, situated in the County of Klamath, State of Oregon, described as follows, to-wit:

Beginning at an iron pin which is at the quarter corner common to Sections 7 and 18, Township 38 South, Range 9 East of the Willamette Meridian, Klamath County, Oregon; thence North 1,333.20 feet to an iron pin, a 1/16th corner of Section 7; thence North 89°39' West 82.96 feet to a point; thence North 6°02' East 676.90 feet to the Southeast corner of the herein described property; thence North 6°02' East 200.00 feet to the Northeast corner; thence North 89°49' West 489.16 feet to the Northwest corner; thence South 6°02' West 90 feet to the Southwest corner; thence South 89°49' East 486.54 feet to the Southeast corner, being the point of beginning, said tract in the NE 1/4 of the SW 1/4 of Section 7, Township 38 South, Range 9 East of the Willamette Meridian, Klamath County, Oregon.
