

KNOW ALL MEN BY THESE PRESENTS, That Vincent O. Cheyne, James L. Cheyne aka James C. Cheyne and Loretta M. Cheyne, hereinafter called grantor, for the consideration hereinafter stated, does hereby grant, bargain, sell and convey unto Vincent O. Cheyne and Diane L. Cheyne, husband and wife, as to an undivided 1/2 interest, hereinafter called grantee, and unto grantee's heirs, successors and assigns all of that certain real property with the tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining, situated in the County of Klamath, State of Oregon, described as follows, to-wit: \*\*\*and James C. Cheyne and Loretta M. Cheyne, husband and wife, as to and undivided 1/2 interest.

A tract of land situated in Farm Unit "C" and Government Lot 6 being in the SE $\frac{1}{4}$  of Section 16, Township 41 South, Range 12 East of the Willamette Meridian, Klamath County, Oregon, more particularly described as follows: Beginning at the East 1/4 corner of said Section 16; thence South 00°14' West 1150.00 feet to the intersection of Broadway and Rosicky Avenue; thence North 89°46' West along the centerline of said Rosicky Avenue and its extension, 2087.16 feet to a point marking the true point of beginning; thence South 00°14' West 216 feet, more or less, to the Northerly right of way line of Depot Road; thence South 71°23'40" West along said right of way line 588 feet, more or less, to the West line of the SE $\frac{1}{4}$  of said Section 16; thence Northerly along the West line of the said SE $\frac{1}{4}$  406 feet, more or less, to a point which bears North 89°46' West from the true point of beginning; thence South 89°46' East 557 feet, more or less to the true point of beginning.
