WITNESSETH: That the Grantor, hereunto authorized by the Act of Congress approved March 1, 1911, (36 Stat. 961, as amended; 16 U.S.C. 485) and the Act of October 21, 1976 (90 Stat. 2743; 43 U.S.C. 1716), the provisions of which have been complied with, for, and in consideration of the conveyance to it by the Grantee of lands in the County of Lake, State of Oregon, as stated in the deed to the United States, the receipt of which is hereby acknowledged, does hereby remise, release, and quitclaim unto the Grantee all its rights, title, and interest in and to the real property situated in the County of Klamath, State of Oregon, described as follows:

T. 32 S., E. 7 E., W.M. sec. 34, SiSiSiWi and SiNiSiSiVi.

T. 33 S., E. 7 E., W.M. sec. 3, lots 3 and 5, S¹₂NW4NW4 and S¹₂NW4; sec. 4, lots 1, 2, 3, and 4, and S¹₂N⁴₂.

Containing 539.20 acres, more or less.

SUBJECT TO treaty rights between the United States and Klamath Indians, more specifically defined as hunting, fishing, trapping, and food-gathering rights (Civil Action No. 77-2628, U.S. Court of Appeals, Ninth Circuit).

TO HAVE AND TO HOLD the above-described real property unto the Grantee and its assigns forever, together with all hereditaments and appurtenances thereunto belonging.
