

REAMORTIZATION OR EXTENSION AGREEMENT

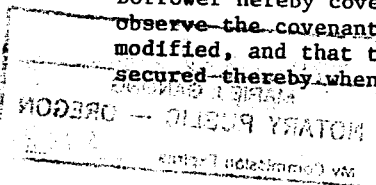

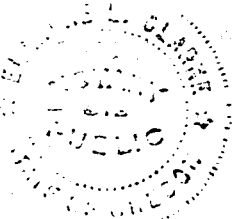
