The Company agrees to extend the term of the contract under the terms of a Transition Plan Agreement dated [REDACTED] for a maximum period of 12 months. The beneficial interest of the service office and advertising advances shall be converted following to the actual amount of the maximum advance thereof. Advances shall not be made more than 30 days from the date of the Transition Plan Agreement, and any balance outstanding after 12 months shall be paid off within 12 months, which is the time of repayment of the advance.

The obligations incurred by the Bank in respect of such a drawdown shall be apportioned to the Beneficiaries, having regard to the proportion of the amounts advanced by the Bank to each Beneficiary. Notwithstanding the amount outstanding at any particular time the sum of all amounts advanced by the Bank to the Beneficiaries shall not exceed the Maximum Procedural Amount. Without affecting the position under the terms of the Financing Loan Agreement, if a portion of the amount on the Beneficiaries' account is deducted and set aside by the Bank for the risk of the Bank, all such amounts advanced without the consent of the Beneficiaries, shall be deducted from the amount available to the Beneficiaries under the terms of the Financing Loan Agreement. Subject to meeting any requirements, all amounts advanced by the Bank shall be retained under the terms of the Financing Loan Agreement, unless the entire outstanding balance is drawn down at once by the Beneficiaries. The relevant bank documents of payment shall be drawn up in accordance with the requirements of the Financing Loan Agreement.
