KNOW ALL MEN BY THESE PRESENTS That JOHN P. WILHELM and JENNIE L. WILHELM, husband and wife

hereby certify that the grantor, for the consideration hereinafter stated to grant and by THOMAS P. WILHELM and LUCILLE E. WILHELM, husband and wife

hereinafter called the grantor, does hereby grant, bargain, sell and convey unto the said grantor and grantor's heirs, successors and assigns, that certain real property, with the improvements, buildings and improvements thereon belonging or so pertaining, situated in the County of Lincoln, and State of Oregon, described as follows, to-wit:

A tract of land situated in the NW1/4 SE1/4 of Section 14, Township 33 South, Range 9 East of the Willamette Meridian, more particularly described as follows:

Beginning at an iron pin on the West boundary of Boardwalk Road, said point being West a distance of 30.0 feet and South a distance of 130.0 feet from the Northeast corner of SW1/4 SE1/4 of said Section 14; thence South along the West boundary of Boardwalk Road a distance of 123.0 feet to an iron pin; thence West a distance of 523.3 feet to an iron pin on the Easterly right of way line of lateral 7-5 (or lateral 1-3-5) thence northeasterly along said Easterly right of way line to an iron pin located West a distance of 470.6 feet from the above described beginning point; thence East a distance of 470.6 feet, more or less to the point of beginning.

To Have and to hold the same unto the said grantor and grantor's heirs, successors and assigns forever

And the grantor hereby covenants to and with said grantor and grantor's heirs, successors and assigns, that grantor is lawfully seized in fee simple of the above granted premises, free from all encumbrances except those of record, common to the area and apparent on the ground

grantor will warrant and defend the said premises and every part and parcel thereof against the lawful claims and demands of all persons whomsoever, except those claiming under the above described encumbrances.
