During this time he made a tour of the continent, and visited nearly all the countries of Europe, except Russia, and the Island of Sicily. He also made a short visit to the Island of Madeira, and to the Azores. The author's object in making this tour was to study the history and manners of the people, and to observe the condition of the world, as it then existed.
