Notice of Location of Placer Claim

STATE OF OREGON, County of Clatsop

NOTICE HEREBY IS GIVEN That the undersigned locators, each a citizen of the United States or one who has declared his intention to become such, have discovered a placer deposit of locatable minerals upon the public domain of the United States which is open to mineral entry and location within the above state, county and mining district, and, in accordance with the laws of the United States and the State of Oregon, have located and hereby do locate a placer claim of 160 acres by posting this notice of location as a post or monument in a conspicuous place inside the boundaries of the claim. The claim is named the Savage NE 1/4 43 (Savage Tree)

Claim, which is described as follows (fill out one of the two sections below):

This claim occupies the Northwest Quarter of Section 39, Township of 29 South, Range 7 East, of the Wapinitia Meridian in the State of Oregon.

This claim is situated in the Northwest quarter section of Section 39, Township of 29 South, Range 7 East, of the Wapinitia Meridian, either as surveyed by the U.S. Government or patented if the land is unsurveyed.
