POWER OF ATTORNEY

(General)

KNOW ALL MEN BY THESE PRESENTS:

debts, dues, bonds, notes, checks, drafts, accounts, deposits, legacies, bequests, devises, interests,
benefits and proceeds, certificates of deposit, annuities, pension and retirement benefits, insurance
benefits and proceeds, documents of title, choses in action, personal and real property, intangible and
tangible property and property rights, and demands whatsoever, liquidated or unliquidated, as are now

or shall hereafter become due, owing, payable, owed, or belonging to me or in which I have or may
acquire an interest, and to have, use, and take all lawful ways and means and legal and equitable remedies,

proceedures, and writs in name for the collection and recovery thereof, and to compromise, settle,

and agree for the same, and to make, execute, and deliver for me and in name all instruments,
acquittances, releases, receipts, or other sufficient discharges for the same.

(c) To improve, repair, maintain, manage, lease, sell, release, convey, subject to liens,
mortgage, and hypothecate, and in any way or manner deal with all or any part of my real or personal
property, tangible and intangible, whatsoever, or any interest therein, which now own or may

hereafter acquire, for me and in name, and under such terms and conditions, and under such
covenants as attorney shall deem proper.

3. This instrument is to be construed and interpreted as a general power of attorney. The enumeration of specific items, acts, rights or powers herein does not limit or restrict, and is not to be construed or interpreted as limiting or restricting the general powers herein granted to my attorney in fact.

4. By executing this document I further intend to provide all previous general power of attorney appointments executed by me or on my behalf.


