As provided by sections 527A, 5272, and 5273 of the Internal Revenue Code, section 527(c) shall have effect for years (including calendar and non-calendar years) beginning on the first day of the calendar year in which the calendar year 1997 has been reached, but it shall not apply to the calendar year 1997. Therefore, there is a lien in favor of the United States on all property and rights to property belonging to this taxpayer for the amount of those taxes, and additional penalties, interest, and costs that may accrue.
