C., HEREBY CALLS FOR THE CONSIDERATION OF THE STATE, CITY, COUNTY, TOWN, VILLAGE AND CORPORATION UNDERTAKING, KNOWN AS THE "CITY OF CLACKAMAS FALLS, OREGON", AND ITS OFFICIAL AGENT CALLED GRANTOR, AND WITH GRANTOR'S FULL KNOWLEDGE AND CONSENT, ALL OF THE GRANTOR'S RIGHTS, TITLE AND OWNERSHIP IN THE LAND AND PROPERTY HELD BY THE STATEMENT, HEREBEATEN AND DOCUMENTATION THEREON BEINGHEREBY FOR THE FOREGOING, ASSUMED IN THE COUNTY OF CLACKAMAS.

Some of Oregon, bounded on the west by the Columbia River, and on the east by the Willamette River, and on the north by the Coast Range, and on the south by the Cascade Range, situated in the County of Clackamas, Oregon.

1. To have and to hold the water unto the said Grantor and grantee's heirs, successors and assigns forever.

2. That the said actual satisfaction paid by the Grantee, stated as herein, is full and complete.

It is further agreed between the parties that the instrument shall be binding upon them, notwithstanding any changes that may be implied to make the provisions herein apply equally to corporations and to individuals.
