Order, with respect thereto according to the name of a permanent
or temporary member, to be due and payable.

2. To promote, manage and maintain real property as good investments and resources and to conduct or manage business or enterprises which may be carried on by means of such property.

3. To construct or improve property and to lease and sublease such property or any part thereof for residential, commercial, agricultural, industrial and other uses of such property.

4. To acquire title to all such properties, regardless of ownership, interest and/or claim thereto, subject to the following conditions:

(a) That the acquisition will be conducted in accordance with the provisions of the Constitution of the United States and the laws of the Commonwealth of Massachusetts; and

(b) That the acquisition will be made for the purpose of using the same in the public service either as offices or as places to meet the needs of the people.

4. The government and the Commonwealth governments are to be encouraged to increase their contributions to the World Health Organization and other international health organizations. The World Health Organization should be encouraged to increase its contributions to the Commonwealth, except that priority should be given to the promotion of health in developing countries.

5. The Commonwealth and the World Health Organization should be encouraged to increase their contributions to the promotion of health in developing countries.


