DESCRIPTION OF LAND

A tract of land situated in the SE 1/4 NE 1/4 of Section 33, Township 28 South, Range 11 1/2 East of the Willamette Meridian, Clatsop County, being more particularly described as follows:

Beginsing at a point on the East Line of said SE 1/4 NE 1/4 from which point the Northeast corner of said SE 1/4 NE 1/4 bears South 00 degrees 02' 28" East 310.00 feet; thence South 00 degrees 02' 28" West on said East Line, 173.96 feet; thence South 11 degrees 11' 50" West, 432.52 feet; thence South 00 degrees 07' 04" West 776.32 feet to a point on the West Line of said SE 1/4 NE 1/4; thence North 00 degrees 11' 13" East on said West Line, 137.61 feet to the Easterty Clatsop County Deed Records; thence Northeastly along said Easterty Line to a point on the South Line of said SE 1/4 NE 1/4; thence North 07 degrees 29' 53" East on said South Line, 561.38 feet to the Northwest corner of a tract of land described in Deed Volume 47 at page 552, Clatsop County Deed Records; thence South 00 degrees 04' 28" West on the West Line of the last mentioned tract of land, 300.00 feet to the Southwest corner thereof; thence North 09 degrees 25' 51" East to the South Line of the last mentioned tract of land, 300.00 feet to the point of beginning of this description.

Beginsing at the Northwest corner of said SE 1/4 NE 1/4; thence North 09 degrees 19' 53" East along the South line of said SE 1/4 NE 1/4, 316.56 feet to the Westerty Line of a tract of land described in Deed Volume 47 at page 553, Clatsop County Deed Records; thence Southeastly along said Westerty Line to the West Line of said SE 1/4 NE 1/4; thence North 00 degrees 13' 13" East along the West Line of said SE 1/4 NE 1/4, 508.39 feet to the point of beginning.
