A parcel of land in the NW 1/4 of Section 11, Township 14 South, Range 11 East, described as follows: Beginning at a point on the East Line of said NW 1/4 of which bears S. 0° 25' 19" E., a distance of 231.34 feet from the Northwesterly corner of said NW 1/4, said point also being the northerly corner of Lot 1, Block 22, First Addition to Homestead, running thence Northwesterly along the Northerly line of said Lot 1 to the northerly corner thereof; thence N. 0° 25' 19" E., a distance of 231.34 feet to a point; thence S. 88° 53' 55" E., a distance of 117.34 feet, back or bent, to the east line of said NW 1/4; thence S. 0° 25' 19" E., along said east line a distance of 231.34 feet, back or bent, to the point of beginning.


