 demands, garnishments, and accept the same and payment thereof and all bonds and other securities in the like manner and
 to issue, set, execute, bargain, sell, release, transfer, convey and perfect any leases, assignments and transfers, including
 the right of reversion or any of the same for such price, value and terms and conditions and with such covenants as are usual
 therein and therefor, to sell, transfer and deliver all or any interest of which I hold for me or my representative or any other
 trustee, guardian, fiduciary and to whom ever may be the same, to bargain for, sell, let, mortgage, hypothecate and in any
 other way and manner find it and with goods, wares and merchandise, choses in action, and other property or possessions of

 do any business with any bank or banker on my behalf, and
