Johnson, Commissioner of Land Management, do hereby grant, bargain, sell and convey unto the said grantee and grantee's heirs, executors and administrators, all rights, title, interest and property, with the appurtenances thereto belonging or appertaining, situated in the County of Clatsop and State of Oregon, described as follows, to wit:

The Southwesterly cornering 16 acres of Lot 9 and the Northeasternly cornering 16 acres of Lot 10, Block 10, Section 10, Clatsop Co., in the City of Clatsop Mills, according to the official plan thereof on file in the office of the County Clerk of Clatsop County, Oregon.

SIXTY-THREE (63) Reservations, restrictions, covenants and rights of way of record and those apparent on the land, if any.

To have and to hold the same unto the said grantee and grantee's heirs, executors and administrators, and said grantee hereby covenants to and with said grantee and grantee's heirs, executors and administrators, that grantee is lawfully seized in fee simple of the above granted premises, free from all encumbrances, except as above stated.

Grantee will warrant and forever defend the said premises and every part and parcel thereof against the lawful claims and demands of all persons whatsoever, except those claiming under the above described encumbrances.

The sum and actual consideration given or received other property or value given or received effect to the above consideration (including which it is understood between the parties), shall be deemed to have been \$ 15,000.00.
