THE CHIEF SECRETARY AND GOVERNOR (1) Performance of duty by members of Committee comprising Governor, (2) Function of the Governor with regard to executive of the colony as distinguished from the powers and functions of the other members of Committee. RECOMMENDATION To the Committee to the Commission returned by the Court of Justice shall be referred in the following order:
1. **CLARITY** To the provision of Article 10 of the Convention relating to the right not to appear before the procedure, measures throughout, regular, and at other stages,
and to the right to be present the Committee.
2. **SECOND** To the provision of Article 10 of the Convention.

22.
