TRACT 1: A tract of land situated in the County of Washington, State of Oregon, more particularly described as follows, beginning at the intersection of the southerly right of way line of the Great Northern Railway Company's right of way and the West line of said recorded Tract 2, 1977, in Volume 209, Page 300; thence southerly 900 feet along said southerly right of way line and 266.5 feet to the intersection of the West line of said right of way line and the southerly right of way line of the Great Northern Railway Company's right of way, said southerly right of way line being 1000 feet wide, in Volume 22, Page 327, Deed Record of Multnomah County, Oregon; thence Southward at right angles 100 feet; thence Eastward and parallel to said southerly right of way line to the southerly right of way line of said recorded Tract 2, Page 300, Deed Record of Multnomah County, Oregon; thence East to the right of way line.

TRACT 2: A tract of land situated in the County of Washington, State of Oregon, more particularly described as follows, beginning at a point on the southerly right of way line of the Washington Western Railroad Company's right of way, said point being approximately a distance of 300 feet Northward along said southerly right of way line from the intersection of said right of way line with the West line of said property situated in Deed Volume 209, Page 300, Multnomah County Deed Record; thence East along said right of way line to the southerly right of way line of said recorded Tract 1, a distance of 266.5 feet, measured at right angles from the centerline of the Washington Western Railroad right of way.
