NOTICE OF DEFAULT AND ELECTION TO SELL

Reference is made to that certain trust deed made by Donald R. Hampson and Janet E. Hampson as grantor, to Klamath County Title Company as trustee, in favor of Motor Investment Company as beneficiary, dated February 2, 1987, recorded February 3, 1987, in the mortgage records of Klamath County, Oregon, in book/reel/volume No. M87 at page 1706, fee/file/instrument/microfilm/reception No. 71018, or as property situated in said county and state, to-wit:

The South half of Lot 12 in Block 2 of Second Addition to Altamont Acres, according to the official plat thereof on file in the office of the County Clerk, Klamath County, Oregon.

Notice hereby is given that the beneficiary and trustee, by reason of said default, have elected and do hereby elect to foreclose said trust deed by advertisement and sale pursuant to Oregon Revised Statutes Sections 86.705 to 86.795, and to cause to be sold at public auction to the highest bidder for cash the interest in the said described property which the grantor had, or had the power to convey, at the time of the execution by him of the trust deed, together with any interest the grantor or his successors in interest acquired after the execution of the trust deed, to satisfy the obligations secured by said trust deed and the expenses of the sale, including the compensations of the trustee as provided by law, and the reasonable fees of trustee's attorneys.

In construing this notice, the masculine gender includes the feminine and the neuter, the singular includes the plural, the word "grantor" includes any successor in interest to the grantor as well as any other person owing an obligation, the performance of which is secured by said trust deed, and the words "trustee" and "beneficiary" include their respective successors in interest, if any.
