WHEREAS, Weyerhaeuser and Grantee desire to supplement the Original Agreement to include said SE%SE% of Section 32,

NOW, THEREFORE, the Original Agreement is hereby supplemented as follows:

Weyerhaeuser, for and in consideration of the termination and quitclaim of Grantee's rights held by virtue of said Telephone and Telegraph Line Right of Way Special Use Permit, hereby grants and conveys to Grantee, its successors and assigns, an easement, five (5) feet in width, for the purpose of assigns, maintaining and repairing Grantee's existing telephone operating, maintaining and repairing Grantee's existing telephone line over and across the said SEWSEW of said Section 32. The line over and across the said SEWSEW of said Section of the easement is two and one-half feet (2%') on each side of the

centerline located approximately as shown in red on the attached Exhibit A.

The easement hereby granted is granted subject to all matters of public record, to all unrecorded permits, leases and licenses, if any, and to all matters which a prudent inspection of the premises would disclose.

In consideration of the grant hereinabove made, Grantee hereby quitclaims and releases unto Weyerhaeuser any and all rights it holds by virtue of said Telephone and Telegraph Line Right of Way Special Use Permit, dated December 27, 1972, as such rights pertain to said SE%SE% of said Section 32.

EXCEPT as herein supplemented, all of the terms and conditions of the Original Agreement shall remain in full force and effect.


