
Lots 4 and 5, Section 9, Township 41 South, Range 8 East, Willamette Meridian, Klamath County, Oregon; excepting that part thereof lying within the right-of-way for U.S. Highway No. 97 as same is now located over and across above premises; subject to easement and right-of-way for power transmission lines as same extend over and across said premises.

The true consideration of this conveyance is \$1,400.00 to be paid in full by the Division of State Lands to settle the claim of the Klamath Drainage District against the state for the transfer of herein described real property.

This deed is issued pursuant to Attorney General's Opinion 8174, dated August 22, 1985, which alters the state's position relative to ownership of herein described real property.

This instrument does not guarantee that any particular use may be made of the property described in this instrument. A buyer should check with the appropriate city or county planning department to verify approved uses.
