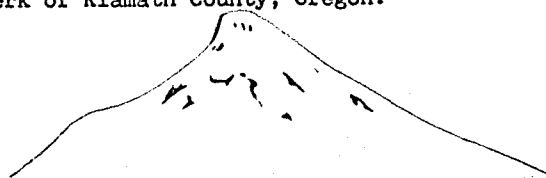


KNOW ALL MEN BY THESE PRESENTS, That.....MARTHA ACHABAI

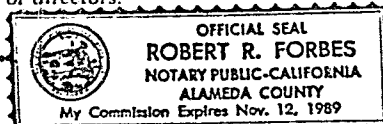
