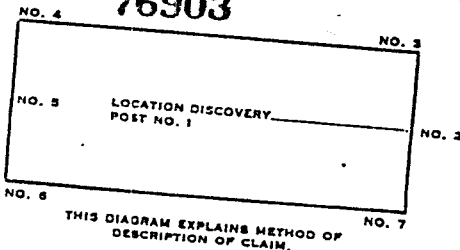

 Notice of Mining Location

NOTICE HEREBY IS GIVEN that the undersigned locators, each a citizen of the United States or one who has declared his intention to become such, have discovered a vein or lode of mineral bearing rock in place upon the unappropriated public domain of the United States within the State of Oregon and said Mining District; and, in accordance with the laws of the United States, of the State of Oregon and the regulations of said Mining District, have located and do hereby locate a claim upon such vein or lode by posting this notice of such discovery and location on a substantial post at the point of discovery, marked Post No. 1. The name of the claim is E.D.H. #5 as follows:

 Commencing at a post marked No. 1 (Discovery Post), from thence
 0 feet in a Easterly direction to an end post marked No. 2, thence
 300 feet in a Northerly direction to a corner post marked No. 3, thence
 300 feet in a Westerly direction to a corner post marked No. 4, thence
 1500 feet in a Southerly direction to an end post marked No. 5, thence
 300 feet in a Southerly direction to a corner post marked No. 6, thence
 1500 feet in a Easterly direction to a corner post marked No. 7, thence
 300 feet in a Northerly direction to said end post marked No. 2.
 The locators claim 0 feet in a EAST end line and
 direction from point of discovery to the WEST 1500
 feet in the opposite direction from point of discovery to the
 300 feet on each side of the middle of said vein or lode, further claiming all the surface rights,
 privileges and minerals, with all dips, spurs, angles and variations, and other rights granted by existing laws
 and customs. This claim is further described as being _____ feet from a natural object or permanent monu-

In construing this location notice, the singular includes the plural and vice versa, where the context so requires.
