300 feet in a Northerly direction to a corner post marked No. 3, thence

300 feet in a Southerly direction to an end post marked No. 5, thence

300 feet in a Southerly direction to a corner post marked No. 6, thence

1500 feet in a Easterly direction to a corner post marked No. 7, thence

300 feet in a Northerly direction to said end post marked No. 2.
