 singular includes the plural.

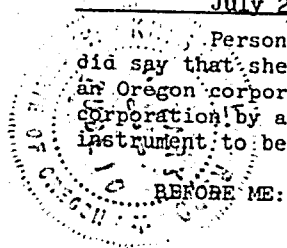
