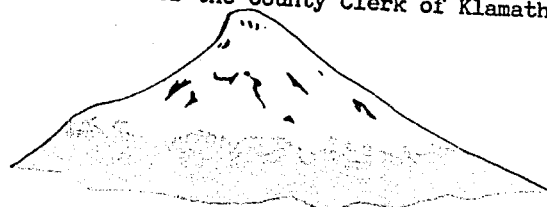
HUSBAND AND WIFE
