6. The Form UCC-1A should be filed with the county filing officers who record real estate mortgages.

9. When filing is to be terminated the acknowledgment copy may be sent to the filing officer signed by the secured party or assignee or he may use Form UCC-3 or UCC-9A as a Termination Statement.
